- AMCMC 1) A letter has been written to the Rail Explorers that states that "ACHS has duly relinquished its one-half interest in the Amador Central Railroad which was held in partnership with the Recreational Railroad Coalition Historical Society (RRCHS) and attached ACHS "approved Minutes for 3/16/22, 4/20/22, and 5/19/22 wherein the Board of Directors took action to dissolve the JVA between the ACHS and the RRCHS and to execute the transfer of ownership as stated above." The Rail Explorers is a company that makes rail bikes available for rent on a designated RR with some of the funds generated being shared with the AMC Corp. That group is still interested in making a deal with the AMCRR. 2) Consideration of disposition the lone depot is before the lone Planning Commission & City Council.
- **EVENTS 1)** A date in May for the Wine & Cheese event rather than in September will be considered. **2)** The Wagon Train Parade will include a Kiddie parade next spring.
